The Legislative Affairs Team sends out a big **THANK YOU** to our Corporate Partners who helped to make the 2013 legislative session a success by reading, reviewing, and supplying facts and data on legislation with potential impact to Georgia Power.

Did you know

During the 2013 Legislative Session, members of the Georgia General Assembly introduced **695** House bills, **272** Senate bills, **1038** House resolutions, and **699** Senate resolutions.

Of those bills and resolutions, Debbie Burris sent out **130** for review by Georgia Power subject matter experts to determine the effects of these bills on Georgia Power.

The legislative affairs team is actively tracking **46** bills and resolutions as amend, support, oppose, neutral or monitor in status.

11 bills have already been signed by Governor Nathan Deal.

Legislation that did not pass or fail in both chambers during the 2013 legislative session will carry over into the 2014 session at which time those bills and resolutions may be taken up for consideration. Additional bills may also be introduced during the 2014 legislative session.

Solar Initiative

The Rural Georgia Economic Recovery and Solar Resource Act of 2014, HB 657 by Rep. Rusty Kidd

(I-Milledgeville) is a bill authorizing the Public Service Commission to establish a rural community solar initiative and charges the PSC with managing responsible expansion of solar energy in the state of Georgia. The PSC would be responsible for determining if any federal funds or tax incentives would be available for the program. In addition, the bill authorizes the PSC to select a "Community Solar Provider" as the sole developer of solar generation facilities throughout the state.

HB 657 would charge the PSC with setting a long-term target for solar capacity and mandate a minimum amount of solar electricity that must be purchased by the electric utility regardless of customer enrollment in the program. The PSC would set the rate the CSP would be paid by the electric utility for the purchase of the mandated solar generation.

According to the bill, the Community Solar Provider would:

- own, operate and maintain their own solar facilities
- conduct an RFP for excess solar demand
- sell solar electricity to the electric utility
- coordinate solar development in Georgia

The bill specifically states that there would be no change to the Georgia Territorial Act of 1973, but in areas where there is a conflict, the Rural Georgia Economic Recovery and Solar Resource Act of 2014 would supersede the Territorial Act. **Georgia Power opposes the bill.**

Ethics Reform

In the July Primary Elections, over 1 million Georgia citizens voted in favor of limiting lobbyist spending at the State Capitol on non-binding questions on the Republican and Democratic ballots. In response, **House Speaker David Ralston (R-Blue Ridge)** introduced **HB 142** and **HB 143**. After extensive work done during the committee process, both bills were voted on in the House on Monday, February 25. HB 142 passed 164-4 and HB 143 passed 167-0. Georgia Power is neutral on both bills.

The major provisions for HB 142 include:

- Re-establishing the rule making authority to the Georgia Campaign Finance and Transparency Commission, this authority was stripped by former Speaker Glenn Richardson.
- Bans spending by lobbyist for gifts, dinners and event tickets, but allows for events for the whole General Assembly, and groups such as committees, caucuses, and local delegations.
- Expands the definition of a lobbyist to require registration for unpaid individuals who lobby on behalf of
 organizations.
- Changes reporting requirements for registered volunteer lobbyists who do not spend money on legislators.

 Takes away the annual registration requirement for volunteer lobbyists who spend no more than five days at the General Assembly.

HB 143 includes:

- Requirement for members of the General Assembly to file disclosure reports to report any money raised between January 1 and the start of the legislative session.
- Allows local elected officials to file disclosure reports at a local level instead of with the state.
- Removes the disclosure filing requirements for city and county officials who raise \$2,500 or less in campaign contributions or expenditures.
- Changes reporting requirements from four times per year to two times per year during an election year for local officials with contributions or expenditures that fall between \$2,500 and \$5,000.

Both bills now head to the Senate for the committee process and a floor vote. In January, the Georgia Senate adopted a rule governing only the Senate chambers that placed a cap of \$100 on lobbyist spending. The passage of **HB 142** and **HB 143** by both chambers supersedes the Senate rule.

Nuclear Financing

HB 267 by **Rep. Jeff Chapman (R-Brunswick)** is a bill aimed at limiting the amount of profit that Georgia Power will be allowed to earn on costs that are above the certified amount for units 3 and 4 at Plant Vogtle.

Currently, the Georgia Public Service Commission has the authority to review and approve/disapprove costs of the project. Georgia Power files reports to the PSC every six months, which are then reviewed by an independent construction monitor for management and prudency of the dollars spent. The process, along with Nuclear Regulatory Commission supervision provides for extreme oversight and scrutiny of every aspect of the construction project.

The bill was heard on Tuesday, February 26 in a sub-committee of the House Energy, Utilities and Telecommunications committee. **Georgia Power opposes the bill.**

GPC Sales Tax Exemption

HB 418 and **HB 419** by **Rep. Barry Fleming (R-Harlem)** are two bills currently in the House Ways and Means committee that directly affect the sales tax exemption that Georgia Power receives for machinery used in the generation of electricity. **Georgia Power opposes both bills.**

- HB 418 is an attempt to allow counties to use confidential taxpayer information to research inconsistencies in the distribution of taxes from the State of Georgia. This bill would place an administrative burden on GPC to answer questions regarding refunds, exemptions and inconsistencies in county tax amounts. The State Department of Revenue has the authority to oversee the collection of taxes and to ensure that all taxpayers are treated fairly and in a consistent manner.
- HB 419 seeks to remove electrical power generating facilities from the definition of a manufacturer for sales and use tax purposes. Georgia Power currently receives the exemption for sales and use tax on machinery and equipment used in all generating facilities. If passed, this bill will significantly increase costs and in turn, those costs to the company would be passed on to the customer.

Solar Tax Credits and Exemptions

HB 348 by Rep. Don Parsons (R-Marietta) is a bill that allows tax credits for alternative fuel vehicles. The bill is currently in the House Ways and Means committee. Georgia Power is neutral on this bill.

HB 430 by **Rep. Don Parsons (R-Marietta)** is a bill that qualifies equipment used in solar installations for a sales and use tax exemption. The bill would benefit Georgia Power and its customers due to the company's move toward more solar generation. **Georgia Power supports this bill.**
